Definitions and types of endowments in KSA

The term "waqf" (endowment) is understood in the jurisprudence of the Hanafi, Shafi'i, and Hanbali schools of thought as "holding and preserving wealth for the sake of Allah Almighty." It refers to dedicating a specific property or asset for charitable or religious purposes, where the asset remains intact, and its usufruct (benefits) are used for the designated cause. In simpler terms, it is the act of donating property for a specific religious or charitable purpose, and the property itself cannot be sold, gifted, or inherited. The owner of the property (the "waqif") cannot use or transfer the property for personal gain, as it becomes dedicated to the intended purpose. The property becomes a "locked" asset, dedicated to the cause, and the usufruct is distributed according to the conditions set by the donor. It is a religious motivation to draw closer to Allah Almighty through virtuous deeds such as charity, kindness, and acts of goodness. These acts benefit members of the Muslim community and create social value, with the reward of those who benefit from them. It is also a developmental motivation with great significance, which is why Muslims have prioritized it. They have hastened to establish charitable institutions such as mosques, schools, hospitals, and orphanages, equipping them with Qur'ans and providing them with charitable contributions to become sources of goodness and light. All these supporting services, such as drafting the endowment deeds, proving them before the competent court, establishing endowment companies and institutions, and setting up the administrative structure, policies, and procedures, are provided by Al-Towyjry Law Firm. ➤ **The types of endowments (waqf) that are approved based on the beneficiary of the endowment:**

➤ **The Family Endowment (Waqf Dhurri)**

The family endowment (Waqf Dhurri) benefits only the relatives of the donor (waqif), and the profits derived from it are allocated to the waqif. It allows the donor to specify the beneficiaries, either from their own family or others. For example, the donor may say: "I dedicate my house as an endowment for my descendants after my death."



Endowments

» Charitable Endowment (Waqf Khayri)

It refers to the allocation of the profits derived from the endowment's assets for charitable purposes, such as supporting mosques, hospitals, orphanages, and other charitable institutions. The donor specifies the use of these profits, such as for a hotel, institution, or project, to be funded by the income generated for the benefit of specific needs, like providing for the poor, orphans, or for supporting the teaching of Islamic jurisprudence.

» The common endowment (Waqf Mushtarak)

This type of endowment is initially dedicated for a certain charitable purpose for a specific duration, and afterward, it may be redirected. For example, the donor may say: "I dedicate the fruits of this land to the poor and my relatives for ten years, and afterward, it will go to my descendants." Alternatively, the endowment may first benefit the descendants for a fixed period and then shift to a charitable purpose. For instance, the donor may say: "I dedicate the fruits of this land to myself and my children for one year, and afterward, it will go to the poor." In some cases, all parties (the poor, descendants, etc.) may be included in the endowment.

- Handling cases directly related to endowments and wills, including adding new cases for endowment or will-related issues.
- Handling approvals for the transfer or sale of endowment property.
